As we approach the conclusion of Fiscal Year 2024 (FY24) and set our sights on Fiscal Year 2025 (FY25), we are staying in touch with important end of year information regarding Intergovernmental Agreements (IGA), Capital Outlay balances, the NM Grown opportunity and ALTSD – OIEA quarterly meeting announcement.

ALTSD's Office of Indian Elder Affairs has been in contact with Tribal Senior and Adult Day Services Directors regarding the remaining balance of allocated funds relative to your FY24 IGA. It is critical that all reimbursement requests, invoices and additional documents are current. Yearly, our collective objective is for 100% expenditure as this provides justification for the following Fiscal Year's funding allocation. Please don't hesitate to reach out to us with any questions or concerns regarding the balance of your FY24 funding, including Capital Outlay funds received directly from New Mexico ALTSD. Our goal is to support all Tribes, Pueblos and Nations in expending all the ALTSD funding available to you.

By now, you should have received your FY25 IGA, which will come into effect on July 1, 2024. If you have not yet received it, please promptly inform Melissa Sanchez at melissa.sanchez@altsd.nm.gov to expedite the process. The signing of your FY25 agreement must be completed and signed no later than June 7th, 2024.

Additionally, ALTSD's Office of Indian Elder Affairs has been in contact with Tribal Senior and Adult Day Services Directors, and we extend our sincere appreciation for your participation in the New Mexico Grown program. Your involvement supports local producers and enhances the quality of nutrition for elders at their local centers. We want to emphasize that this program is free to you. We strongly encourage and hope you will take full advantage of its benefits and expending the allocated funds. Thank you for your commitment to promoting locally sourced foods and contributing to the well-being of your community.
